**GENERAL CLAUSE**

01. Suppliers are to present their proposal on their latest model mentioning country of origin.
02. Free factory training for 03 days with hotel accommodation (less air passage) is to be given by the tenderer to 02 BFCC personnel.
03. BFCC reserves the right to carry out pre-shipment inspection at the manufacturing facilities (Air passage & hotel accommodation are to BFCC's account) and have the right to reject the unit if the same does not comply with the accepted offer. Besides, notification for pre-shipment inspection should be given by supplier/manufacturer at least 25 days ahead of shipment.
04. 02 (Two) sets each of manuals for maintenance, operation & parts catalogue must be provided for the equipment at the time of delivery.
05. All optional items, if any, are to be mentioned in technical offer & must be mentioned with the price of the optional items in financial offer only.
06. The manufacturing company must have to confirm by writing for providing after sales service facilities in the region and should include smooth supply of spares for at least next 10 (Ten) years.
07. The delivery schedule of destination must be within 04 months from the date of received L/C failing which penalty will be imposed. Therefore, the supplier/manufacturer will plan accordingly.
